

# MEDIA ACCREDITATION FORM PDC EUROPE 2025

All media representatives who wish to attend one of our events must complete this accreditation form and apply for media accreditation before the respective event.

## GENERAL RULES

Media representatives are asked to refrain from taking private photos with the players and asking for autographs. Only photographers with accreditation are allowed access to the stage area.

## PHOTOGRAPHERS

Please note that due to limited space, freelance photographers may be required to provide specific proof of assignment from an organization or agency.

## ACCREDITATION REQUEST

The application form should be completed and returned no later than 14 days prior to the event. Please email it to the PDC Europe Media & Communications Manager, Dunja Fadel: [dunja.fadel@moltkesports.com](mailto:dunja.fadel@moltkesports.com).

Any accreditation forms received after the cut-off date above will be processed at the next available opportunity but cannot be guaranteed. Media representatives who are not accredited in advance will not be granted access to the event. ## PRESS ROOM

The availability of a press room is not guaranteed. If available, you will be informed of the location of the press room. Only photographers are allowed access to the stage area in accordance with their accreditation; images must be edited in the press room (if available) or outside the playing/spectator area. The venue and press room (if available) will be closed half an hour after the end of the last match of the respective session.

## INTERNET

The PDC Europe will endeavor to provide media representatives with free Wi-Fi in the press room (if available). The internet connection provided may not be secure and it is the responsibility of the media representative to install appropriate security software. Moltke Sports/PDC Europe does not accept any responsibility for the security of the internet connection or any compromising attacks or intrusions, data loss, etc.

## INTERVIEWS

Post-match interviews will be offered to winning players after any interviews with our broadcast partners have been concluded. Interviews will be conducted at a reasonable distance and media representatives should make appropriate preparations for conducting interviews at that distance to avoid background noise. The winning players are not obligated to give an interview. Please note: Apart from the winners interview, no interviews can be done on Sunday evening session due to timing reasons.

If you have any specific requests, please liaise with the PDC Europe on-site media representatives.

## PHOTOGRAPHS

Photographs taken at the event will be made available free of charge by the PDC Europe's official photographer for editorial purposes. Please contact PDC Europe at [media@moltkesports.com](mailto:media@moltkesports.com) if you wish to have access to these photographs.

## FILMING/AUDIOVISUAL RECORDINGS

Any audiovisual recordings/filming of match images on the European Tour ('match images' are defined as recordings during a match, during the walk-on and recordings of players within the venue) are prohibited and will result in license costs as well as possible legal action and recourse claims if violated. For interviews with players, a separate request must be submitted. Therefore, all permissions regarding the creation of film/audiovisual recordings must be obtained in advance by email from the PDC Europe Media & Communications Manager, Dunja Fadel: [dunja.fadel@moltkesports.com](mailto:dunja.fadel@moltkesports.com). Prior agreement is also necessary for darts galas.

Footage outside of the venue is possible, as is footage inside the venue that is not defined as match images as per paragraph 1 but also needs to be requested. Video material from the event can be made available to the rights holder upon request and with the rights holder's approval, with a corresponding note to the rights holder. The European Tour's rights are held by DAZN or local broadcast partners for events outside of Germany.

## ADDITIONAL INFORMATION FOR MEDIA REPRESENTATIVES – PLEASE READ CAREFULLY

- Please note that this is only an application form and does not guarantee accreditation, as space at the venue is limited. You will be informed of the status of your accreditation by email.
- Photographers will be provided with a special area close to the stage, which will be shown to you upon arrival. Photographers may only take pictures from the assigned positions.
- Except during the award ceremony, photographers are not allowed to use flash (although the stage lighting should be sufficient even during the award ceremony). We also ask you to use cameras with a shutter release as quiet as possible.
- Photographers must wear dark/black clothing during the event. In addition, no shorts may be worn. Photographers are not allowed to install remote-controlled cameras at the venue.
- Photographers who have been granted media accreditation are entitled to distribute the photos exclusively through the organization(s) indicated on their accreditation form; no further commercial use is permitted.
- By completing and returning this form, media representatives confirm that they (or the organization they represent) have adequate liability insurance and that PDC Europe cannot be held responsible for damaged, lost or stolen equipment.
- Accredited media representatives are expected not to consume alcohol during the event. Furthermore, alcoholic drinks are not allowed in the press room.
- Media representatives should always wear their accreditation badge visibly around their neck and be aware that certain security measures may be in place at the venue,

including bag checks at the entrance. Photos in which the accreditation badge can be seen should not be posted on social media or distributed in any other way.

- Media representatives may bring their own food to the event. We will also endeavor to provide complimentary refreshments. However, food and drink may also be purchased from outlets at the venue.
